1 A I don't recall exactly when it was completed. That
2 sounds about right.

3 Q And when it was completed, did Mr. Terrigno indicate to
4 you that he wanted to submit that application form
5 right away to get the redesignation rolling?

6 A Well, I don't recall that. I don't quite
7 understand your -- like the application, if you're
8 right about the August date, we made the application
9 then. Is this a further question to that?

11 A I'm sorry, I don't understand.

12 Q And, again, I'm not trying to trick you, but my

14 in August, and there was some discussion between Druh

22 A Yes.

23 Q And, in turn, you communicated that to the Terrignos,
24 that, Druh said hold off until after the election?

25 A Yes. I don't remember whether we were all in a meeting
26 together or whether it was just me and her, but that
27 was the -- definitely her concern, to not do it before
